RULES & REGULATIONS

- Parking attendant volunteers must be at least 18 years of age.
- Volunteers should always maintain a professional demeanor. This includes being
 polite, punctual, and respectful to all festival attendees and staff. Provide excellent
 customer service by answering questions and directing attendees as needed. Handle
 disputes or conflicts calmly and professionally. If a situation escalates, involve a
 festival board member.
- Giving away free parking spots is strictly prohibited.
- Wear a shirt with the name/logo of nonprofit and maintain a neat and clean appearance. Provocative, revealing, or offensive attire while on duty is not appropriate.
- Arrive on time for your shift and check in and out with the volunteer coordinator. Notify
 the volunteer coordinator as soon as possible if your group is unable to have the
 minimum number of attendants.
- The festival in an outdoor rain or shine event. Unless we receive a severe weather advisory, we will remain open and operating. Please bring appropriate clothing and shoes for the expected temperature or inclement weather.
- Follow the specific duties assigned to you. If you are unsure about your tasks, ask the volunteer coordinator for clarification.
- Festival will provide tickets, pocket aprons, safety vests, flashlights, informational and directional signage, and security.
- Use festival equipment responsibly and only for its intended purpose. Report any malfunctions or damage. Only enter restricted areas if authorized. Respect boundaries. Return any borrowed equipment or items before leaving.
- Nonprofit volunteer groups may provide their own signage. Signage must approved in advance.
- Do not share sensitive information about the festival or its operations outside of your role. Respect the privacy of attendees and avoid disclosing personal information.
- The use of alcohol or drugs while on duty is strictly prohibited. Any volunteer suspected of using or being under the influence of drugs or alcohol while on duty will be removed from the volunteering. Smoking and vaping are not allowed on festival grounds.

- Avoid inappropriate behavior, including harassment or discrimination, and report any such incidents.
- Adhere to all safety protocols and report any unsafe conditions to the volunteer coordinator immediately. Be familiar with emergency procedures and know the locations of first aid stations and emergency personnel locations. Prioritize your own safety and report any injuries or health issues to the volunteer coordinator immediately.
