



Miss Carencro C'est Bon Seasoning Fest
Queen Agreement

SECTION I - REQUIREMENTS

MISS QUEEN:

- A. Must be and have always been biologically female.
- B. Must be single and have never married.
- C. Must not be pregnant, or have ever been pregnant.
- D. Must not be the adoptive parent of any child.
- E. Must be of good moral character, and not have had an arrest or criminal conviction.
- F. Must relinquish all beauty titles and may not enter any beauty contest of any kind during her reign other than with express and written permission from the CARENCR0 C'EST BON SEASONING FEST PAGEANT DIRECTOR, QUEEN COORDINATOR, or EXECUTIVE BOARD.
- G. Must not have ever before been Louisiana Association of Fairs and Festivals' Queen.
- H. Must not have ever before held the title of CARENCR0 C'EST BON SEASONING FEST MISS QUEEN.
- I. Must have never been stripped of a pageant title.
- J. Must currently reside in: Acadia, Evangeline, Iberia, Lafayette, St. Landry, St. Martin, Vermillion, or St. Mary parishes, unless express permission is given by CARENCR0 C'EST BON SEASONING FEST PAGEANT DIRECTOR, QUEEN COORDINATOR, or EXECUTIVE BOARD.
- K. Must be a citizen of the United States of America.
- L. Must be between 17-23 years of age at the time of the CARENCR0 C'EST BON SEASONING FEST PAGEANT, September 13, 2026.
- M. Must conform to all regulations set forth by CARENCR0 C'EST BON SEASONING FEST.

SECTION II - RULES AND REGULATIONS

- A. MISS QUEEN is a Spokesperson of the CARENCR0 C'EST BON SEASONING FEST. It is the primary role, responsibility, and function of her title. MISS QUEEN is to treat everyone with kindness and respect and always conduct herself with dignity and integrity during her reign in public and on social media.
- B. The term "her reign" as used in this agreement begins when MISS QUEEN is crowned and ends when she crowns her successor.
- C. MISS QUEEN must conduct matters under this contract whether the MISS QUEEN is in crown, banner, regular clothes, formal attire, and whether at a function as a representative or not. From time of crowning until the reign expires, the queen's actions, behavior, and conduct are a representation of the CARENCR0 C'EST BON SEASONING FEST.
- D. MISS QUEEN must maintain regular contact with PAGEANT DIRECTOR or QUEEN

COORDINATOR, either by phone or email, giving her itinerary of upcoming events that she will be attending and her efforts to promote the CARENCRO C'EST BON SEASONING FEST.

- E. MISS QUEEN must use the official CARENCRO C'EST BON SEASONING FEST Pageant email address provided by the organization for all pageant-related correspondence, appearances, and inquiries throughout her reign. CARENCRO C'EST BON SEASONING FEST Pageant official email address is **seasoningfestpageant@gmail.com**.
- F. MISS QUEEN must be available during her reign to represent her title at various functions.
- G. MISS QUEEN must reply within 48 hours of receipt or before the deadline, whichever is first, even if she will not be attending, to all invitations or appearances requests for the duration of her reign.
- H. MISS QUEEN must be present during the entire event or as called for in the invitation when she accepts an invite to an event.
- I. MISS QUEEN must send a written apology to the INVITING DIRECTOR within 72 hours after the event ends if she accepted an invitation, but was not able to attend. A copy thereof must also be provided to the CARENCRO C'EST BON SEASONING FEST PAGEANT DIRECTOR or QUEEN COORDINATOR.
- J. All correspondence regarding MISS QUEEN reign must be answered promptly. Written Thank You notes or an email should always be sent to hosting events attended by MISS QUEEN.
- K. When MISS QUEEN must travel overnight, no one other than a parent/guardian is allowed to travel with QUEEN. No member of the opposite sex, not related by blood, is allowed to travel with QUEEN unless an invitation is extended to them or with express consent of CARENCRO C'EST BON SEASONING FEST PAGEANT DIRECTOR, QUEEN COORDINATOR, or EXECUTIVE BOARD. However, in no event shall that person be housed with MISS QUEEN during that event.
- L. MISS QUEEN is responsible for the maintenance and upkeep of her crown, scepter, banner, crown box, scepter box, train, mantel and other equipment. Any damage caused while in MISS QUEEN's possession will be repaired at MISS QUEEN's expense. MISS QUEEN CANNOT repair any of the items herself or hire someone to repair them. The CARENCRO C'EST BON SEASONING FEST selected repairer must do any repairs. Replacement costs are as follows:
 - Crown \$2,500.00
 - Train and Collar \$2,500.00
 - Banner (each) \$250.00
 - Crown Box \$100.00
 - Scepter \$100.00
- M. CARENCRO C'EST BON SEASONING FEST is the owner of the crown. MISS QUEEN understands that the crown will be passed on from queen to queen each year. MISS QUEEN will receive a keepsake crown on the day of her crowning. If MISS QUEEN feels there are other items needed to make her reign "complete," MISS QUEEN will provide those at her own expense.
 - All items bearing the name CARENCRO C'EST BON SEASONING FEST or the logo must be approved by a Carencro C'est Bon Seasoning Fest Executive Board Member.
- N. In appreciation of her reign and fulfilling her obligations, the MISS QUEEN will receive a scholarship on behalf of the Carencro C'est Bon Seasoning Fest.

SECTION III - PROHIBITIONS, CAUSES FOR REMOVAL AND PENALTIES

MISS QUEEN shall not engage in any of the following actions, each of which may result in penalties, up to and including immediate removal from the title during her reign. At all times, the CARENCRO C'EST BON SEASONING FEST reserves the right, in its sole and absolute discretion, to determine what constitutes a violation of the following prohibitions and to address any conduct deemed inappropriate.

- A. Marry, become pregnant, or be arrested during her reign.
- B. Abuse any controlled dangerous substances during her reign.
- C. Engage in any distasteful conduct unbecoming of a queen during her reign while representing this festival, such as:
 - a. The use of profane, foul, or abusive language in public and/or social media.
 - b. Engage in public displays of affection of any kind by male/female companions while representing CARENCRO C'EST BON SEASONING FEST, or photos of the same posted anywhere by anyone at any time.
 - c. Consume alcohol, tobacco products, or illegal substances while representing CARENCRO C'EST BON SEASONING FEST.
 - d. Engaging in ANY acts or activities characterized as dishonest, immoral, immodest, indecent, in bad taste, which do not comply with the rules set forth by this contract, including gossiping.
 - e. Any other conduct specifically prohibited by the CARENCRO C'EST BON SEASONING FEST.
 - f. Commission of any crime.
- D. Display or share any content, or the appearance of, including but not limited to photos, videos, public comments, messages, etc. on any website or social media platform with the following:
 - a. Politics
 - b. Negativity
 - c. Vulgar, inappropriate, profane, foul, sexual, abusive, or risqué language
 - d. Alcohol (or the appearance of)
 - e. Tobacco (or the appearance of)
 - f. Drugs (or the appearance of)
 - g. Sexual content including provocative of vulgar dancing
 - h. Physical violence of any degree
- E. Disrespect or fail to abide by the Pageant Director, Queen Coordinator, or hosting Festival or Organization's rules.

SECTION IV – DISCIPLINARY PROCESS

The following outlines the process by which alleged violations will be reviewed and addressed. If it is necessary for CARENCRO C'EST BON SEASONING FEST to obtain an attorney to enforce any provisions, the removed or voluntarily resigned MISS QUEEN shall be responsible for any attorney's fees and court costs incurred.

- A. First verified complaint will result in a warning from the Pageant Director or Queen Coordinator.
- B. Second or subsequent complaint, the MISS QUEEN shall appear before CARENCRO C'EST BON SEASONING FEST Executive Board, Pageant Director, and Queen Coordinator, or its authorized representatives, who may take any action it deems necessary.

- C. Marriage, pregnancy, arrest, or for any other item specified herein, shall constitute grounds for immediate removal.
- D. In the event of removal or voluntary resignation, MISS QUEEN shall pay CARENCRO C'EST BON SEASONING FEST \$500.00 representing necessary expenses for the installation and maintenance of the new queen. In addition, removed queen shall return to CARENCRO C'EST BON SEASONING FEST all awards and gifts given at the time of crowning.
- E. In the event of removal or voluntary resignation, the MISS QUEEN shall return all CARENCRO C'EST BON SEASONING FEST property including, but not limited to, crown, train, banners, shirts, scepter, and traveling boxes within 48 hours after notice of termination.
- F. In the event of removal or voluntary resignation, obligations will not have been met. MISS QUEEN forfeits scholarship.
- G. In the event of MISS QUEEN's removal or voluntary resignation, the 1st Runner Up shall be crowned. In the event the 1st Runner Up cannot fulfill this obligation, the CARENCRO C'EST BON SEASONING FEST Executive Board shall select, at their discretion, a MISS QUEEN to fulfill the remainder of that term if they choose.
- H. In the event of MISS QUEEN removal or voluntary resignation, all photographs and social media accounts relating to the MISS QUEEN to the title shall be permanently deleted.
- I. In the event of MISS QUEEN removal or voluntary resignation, the title and all privileges shall be revoked immediately and will revert back to the CARENCRO C'EST BON SEASONING FEST.
- J. If MISS QUEEN breaches any provision of this Agreement, refuses to carry out any service or duty required hereunder, makes a material misrepresentation or untrue statement that causes any warranty or acknowledgment herein to be false, then CARENCRO C'EST BON SEASONING FEST shall have the right to declare this Agreement terminated and, upon the provision of one day's notice to the person, CARENCRO C'EST BON SEASONING FEST may divest the MISS QUEEN of her title and have the sole right to select a successor.

SECTION V - APPEARANCES

- A. MISS QUEEN is responsible for making all arrangements for appearances, except LAFF and/or DC, if required. Pageant Director or Queen Coordinator will make all necessary arrangements for LAFF and/or DC, if required.
- B. MISS QUEEN shall make herself available to any media and public relations events that the CARENCRO C'EST BON SEASONING FEST Pageant Director or Queen Coordinator may arrange.
- C. MISS QUEEN is expected to attend a minimum of twelve (12) approved Festivals during her reign from the list included. A minimum of ten of the twelve festivals must be in District 3 (indicated with an *). If she wishes to substitute a festival not on the list, she must obtain prior approval from the Pageant Director or Queen Coordinator for it to count toward the required total.

- D. While attending an Event by invitation, MISS QUEEN must remain in the designated area the entire time and adhere to any schedule set by the host. While attending a Fair/Festival generally, MISS QUEEN must engage with the public, promote the CARENCRO C'EST BON SEASONING FEST, and attend such event for no less than four (4) consecutive hours at the entire time.
- E. Attending a festival pageant or Queen's event does not satisfy MISS QUEEN's obligation to attend a FESTIVAL to satisfy her contract requirements. Pageants, balls, and events are honors, but MISS QUEEN's first obligation is to promote the CARENCRO C'EST BON SEASONING FEST by meeting and speaking to festival attendees.
- F. MISS QUEEN shall attend all three days of the CARENCRO C'EST BON SEASONING FEST during her reign. She shall arrive 30 minutes prior to gate opening each day and must get approval from the Pageant Director or Queen Coordinator before leaving Festival Grounds for any reason.
- G. MISS QUEEN shall be a hostess to all visiting queens during the CARENCRO C'EST BON SEASONING FEST.
- H. MISS QUEEN must attend the Louisiana Association of Fairs and Festivals convention and participate in activities and competition as directed by the CARENCRO C'EST BON SEASONING FEST EXECUTIVE BOARD.
- A. February 18-21, 2027 in Baton Rouge, LA
- I. MISS QUEEN shall attend all Carencro Cultural District Events and a minimum of one Mercredi Event per season during her reign.
- J. MISS QUEEN shall attend all CARENCRO C'EST BON SEASONING FEST SPRINKLE SQUAD Community Outreach events.
- K. MISS QUEEN shall attend at least two board meetings during her reign to share about her travels and activities with the board of directors.
- L. MISS QUEEN shall attend the CARENCRO C'EST BON SEASONING FEST pageant following her crowning on which date MISS QUEEN's reign shall expire.
- M. If invited, MISS QUEEN shall attend the Mardi Gras Ball in Washington D.C. at the festival's expense (MISS QUEEN Only). MISS QUEEN MUST attend all functions associated with Washington, D.C. Mardi Gras and conduct herself in a ladylike manner for the duration of the trip.
- N. MISS QUEEN may ride in the CARENCRO Mardi Gras Parade. FESTIVAL shall pay entry fee, but MISS QUEEN is responsible for expenses and arrangements with vehicle and throws.
- O. MISS QUEEN agrees to allow the CARENCRO C'EST BON SEASONING FEST to

use her information and photographs from her travels to promote the CARENCRO C'EST BON SEASONING FEST.

- P. MISS QUEEN is expected to be knowledgeable of the CARENCRO C'EST BON SEASONING FEST, history, events, and contests so she will be prepared to answer questions at appearances.
- Q. MISS QUEEN shall make herself available during the week of the festival for public appearances. She will promote CARENCRO C'EST BON SEASONING FEST on Local TV and Radio Stations.
- R. MISS QUEEN shall share about her travels to CARENCRO C'EST BON SEASONING FEST social media accounts to positively promote the CARENCRO C'EST BON SEASONING FEST. When requiring specific hashtags for official or branded post, MISS QUEEN shall use: **#SeasoningFest**, **#SprinkleALilCestBonOnIt**, and **#SprinkleSquad**, along with a hashtag relating the post to the event or occasion being highlighted.
- S. MISS QUEEN shall send pictures of her travels to CARENCRO C'EST BON SEASONING FEST Pageant Director, Queen Coordinator, or Queen Ambassador for posting on CARENCRO C'EST BON SEASONING FEST social media accounts.
- T. MISS QUEEN shall not depend on the other festival queens. MISS QUEEN shall take responsibility for meeting her obligations under this contract. Please communicate with your Pageant Director or Queen Coordinator if you need anything or have questions.
- U. MISS QUEEN shall be a leader to the CARENCRO C'EST BON SEASONING FEST Royalty Family.
- V. MISS QUEEN agrees to hold harmless the CARENCRO C'EST BON SEASONING FEST, Pageant Director, and Queen Coordinator from any loss of personal belongings, accidents, or illnesses occurring during travel or appearances, except where such loss is caused by their gross negligence or intentional misconduct.

SECTION VI – ATTIRE

- A. MISS QUEEN shall maintain appropriate and tasteful attire at all times while representing the CARENCRO C'EST BON SEASONING FEST. Prohibited attire includes, but is not limited to, bare midriffs, backless tops, and excessively short skirts and shorts. Hemlines should be long enough to maintain a polished, elegant appearance all times— standing, walking, and sitting. You should be able to move confidently without needing to adjust clothing.
 - If uncertain about an appropriate length, please ask Pageant Director or Queen Coordinator for guidance.
- B. MISS QUEEN shall purchase and wear when instructed, CARENCRO C'EST BON SEASONING FEST Branded Attire, embroidered with the MISS QUEEN'S logo.
- C. MISS QUEEN shall wear floor length gowns with crown/banner in all parades and formal appearances as instructed by the Pageant Director or Queen Coordinator.
- D. MISS QUEEN shall wear CARENCRO C'EST BON SEASONING FEST crown and banner at all times during appearances, unless otherwise directed by the Pageant Director, Queen Coordinator, or Hosting Director.
- E. Appropriate Attire Expectations include:
 - a. Luncheon or Business attire is defined but not limited to nice modest sundress, skirt, or pants with a nice shirt, crown and banner.
 - b. Formal luncheon or business attire is defined as a suit, skirt or pants, with crown and banner.

- c. Cocktail attire is defined as knee or tea-length formal dress or cocktail pants with crown and banner.
- d. Formal evening wear is defined as a full-length evening gown with crown and formal banner.
 - Any questions concerning attire should be directed to the Pageant Director or Queen Coordinator.
- F. MISS QUEEN is expected to look appropriate and always act her best, including having appropriate amounts of makeup, evening-style for formal wear and interview-style for day or business wear, and hair styling relative to the given event. It is exclusively the CARENCRO C'EST BON SEASONING FEST Pageant Director, Queen Coordinator, or Executive Board's decision if an outfit is inappropriate and their decision is final.

SECTION VII - MISS QUEEN FURTHER UNDERSTANDS AND AGREES:

A) MISS QUEEN'S REIGN ENDS WHEN 2027 MISS QUEEN IS CROWNED.

- Upon completion of MISS QUEEN'S reign, she will be awarded a scholarship. The scholarship is contingent upon full completion of all requirements and obligations and return of crown, collar, and train. She may keep all awards, gifts, banners, and **keepsake crown.**

B) RELEASE OF LIABILITY:

- The MISS QUEEN and Parent/Guardian hereby releases and holds harmless the CARENCRO C'EST BON SEASONING FEST, LLC, its officers, directors, volunteers, sponsors, agents, and affiliates (collectively, the "Festival Team") from any and all claims, demands, damages, causes of action, or liability arising from or related to participation in the pageant and fulfillment of the duties associated with the title. This includes, but is not limited to, travel to and from events, appearances, parades, or any other official functions. The MISS QUEEN assumes all risks associated with participation and agrees that this release shall be binding upon herself, her heirs, legal representatives, and assigns.

C) PHOTO & MEDIA RELEASE:

- The MISS QUEEN and Parent/Guardian grants full permission to CARENCRO C'EST BON SEASONING FEST to use her name, likeness, image, voice, and biographical information in any and all photographs, video recordings, promotional materials, media publications, social media, and advertising associated with the Festival or related events, without compensation or further approval. This release is perpetual and may be used for current and future promotional purposes.

D) AUTHORITY OF THE PAGEANT DIRECTOR AND QUEEN COORDINATOR:

- I understand the Pageant Director and Queen Coordinator are the immediate supervisors of all royalty and any individual representing the Carencro C'est Bon Seasoning Fest. All royalty, family members, and associated persons must follow the Director and Queen Coordinator's instructions. Willful disobedience may result in immediate dismissal. The Director and Queen Coordinator's decisions are final and are fully supported by the Festival Executive Board.

E) CODE OF CONDUCT & MORAL CLAUSE:

- From the date I sign this agreement until the completion of my reign, I will conduct my

activities and life in accordance with the highest ethical and moral standards, and I will not engage in any activity that might bring myself or the CARENCRO C'EST BON SEASONING FEST into public disrepute, ridicule, contempt or scandal or might otherwise reflect unfavorably upon any of the foregoing individuals or entities or might shock, insult or offend the community or any class or group thereof. I acknowledge that, by way of example, and without limiting the generality of the foregoing in any way, appearing in public or permitting myself to be photographed in a state of partial or total nudity or in a lewd, compromising or sexually suggestive manner constitutes a violation of this provision (this includes photographs or images that may appear on any website or social media platform). If, at any time, I am arrested or charged with the commission of a crime (including, without limitation, reckless or drunk driving or minor in possession of alcohol or drugs) or engage in any activities in violation of this provision, then the CARENCRO C'EST BON SEASONING FEST Board may, in their sole judgment, remove my title. CARENCRO C'EST BON SEASONING FEST Board decisions on all matters arising under this provision shall be conclusive.

The Carencro C'est Bon Seasoning Fest MISS QUEEN shall, throughout her reign, receive the guidance, support, and resources necessary to fulfill all duties and responsibilities associated with her title. The Pageant Director and Queen's Coordinator are committed to fostering a positive and enriching experience, taking pride in mentoring the Queen and creating meaningful, lifelong memories. During her term, the Carencro C'est Bon Seasoning Fest MISS QUEEN is expected to represent the festival with professionalism, integrity, and enthusiasm, while actively participating in scheduled events and appearances. The Pageant Director, Queen's Coordinator, and Festival Board look forward to working closely with the Queen and are dedicated to ensuring that her reign is a rewarding and unforgettable experience.
